A vote of Board members is taken by email to approve the document before it is filed by the Treasurer, who is responsible for preparing the Form 990 and supporting schedules.

The Directors are asked whether they understand, and will comply with, the policy. MSM internal controls are also in place to review expenditures and ensure that there are no conflicts of interest when MSM assets or funds are expended.
