# STREET COP MISEUM

## **Overview**

- Last year's operational performance looked like most of the recent years. We had about the same number of operators and a small group supplied 50% of the hours.
- Ridership is comparable to recent years, with the exception of ESL's fall/ winter special events which were negatively impacted by car 265 not being available
- Charters were strong
- Overall revenue (including store sales) continues to perform well
- Safety Emphasis. Throughout the year in all aspects of operations we will be emphasizing safe operations
- Car Availability. For CHSL, the PCC is expected to be available early June. The specific release date may impact the initial PCC schedule. For ESL car 265 will not be available late summer. The good news is that this should have minimal impact on the larger (special event) activities
- Schedule. No material changes from 2023
- Recertification. To support the emphasis on safety we will be returning to in-person quiz taking to ensure appropriate discussion and understanding of the key points



#### **Operations - Volunteers**

#### ROSTER

The ending roster included 111 active operators. This compares to 117 in 2022, 103 in 2021 and 117 in 2019. For the year, almost 85% of the certified operators volunteered contributing approximately 3,810 hours – which is an increase of almost 400 hours over the prior year.

#### **Como-Harriet**

At Como-Harriet we ended the year with 89 active operating personnel compared to 91 in 2022, 81 in 2021 and 90 in 2019.

 A small group of volunteers contributed over 50% of the total operating hours. #### **Excelsior**

At Excelsior we have 28 certified operating personnel compared to 34 in 2022, 27 in 2021 and 43 in 2019.

Like CHSL a dedicated group of volunteers contributed 50% of the total operating hours at ESL.

Pete Cahill, David Downs, and Tom Dulebohn.



#### 2023 Performance - Regular Season - Ridership

Using POS data, the table focuses on regular season (paid by fare) ridership and charter activity by month. As noted in previous years, there is a 25-30% increase in ridership counts when factoring in children or guests riding with passes. In 2022, CHSL had 21,000 total regular season riders (total count), which is about 30% higher than the 2023 total – so year-over-year is essentially flat. ESL's actual ridership count in 2023 was 4,766 compared to 3,527 in 2022.

The fall/winter special events continues to be a large part of the operational revenues. As noted earlier, the ESL events were impacted by the lack of availability of car 265 and finished 2023 at 461 vs. 2,246 in the prior year.
